ONLINE INVESTMENT LICENSE APPLICATION STEPS

- Create an account on: www.ebiz.go.ug/online
- Log into your account
- Fill in the new Investment License registration option
- Upload the required documents (listed from 1-6) in PDF format not exceeding 4MBs.

Ensure the following before logging in:-

- That you have steady internet connection
- That you have a working email address
- That you scan/convert all the documents to PDF
- That your business plan clearly indicates the areas mentioned above.
- That all the details provided are strictly for the shareholders

NB: If the Company Shareholding changed, kindly attach the relevant documents (Company Resolution and Share Transfer forms)
